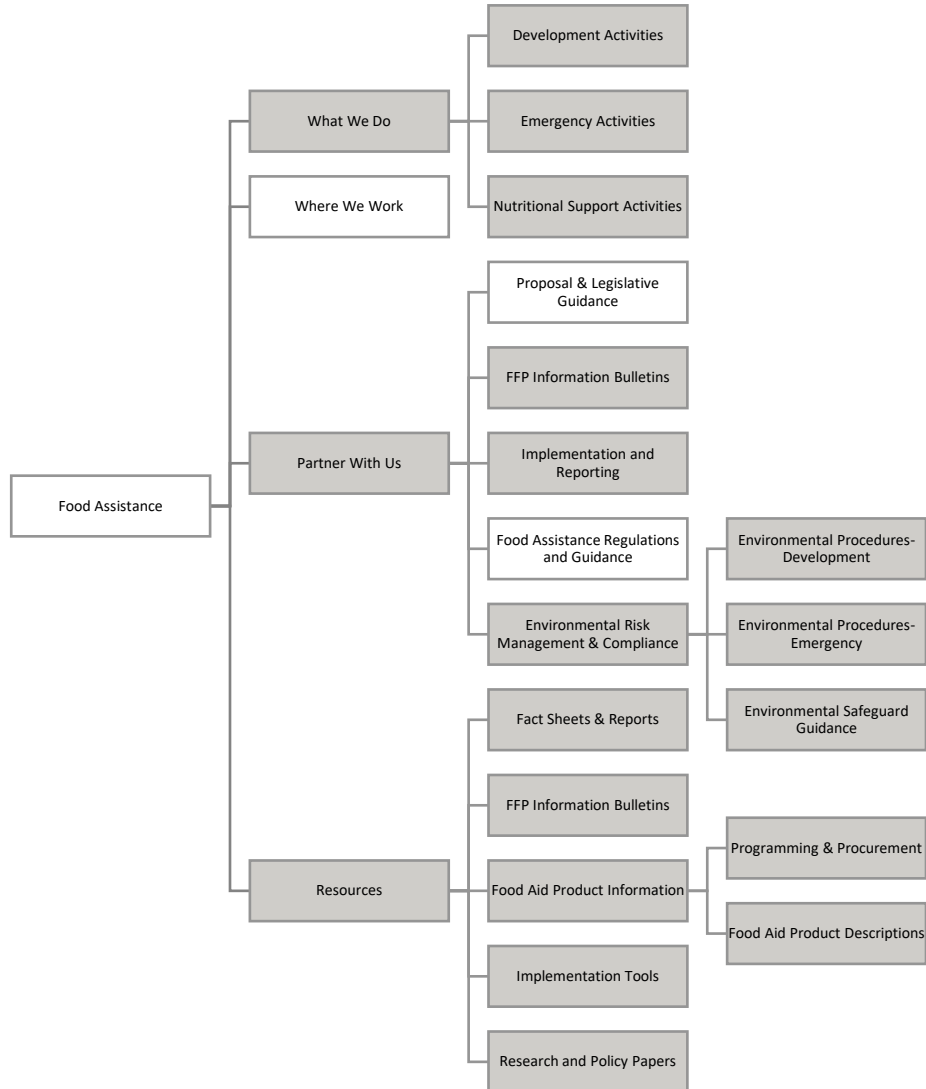
Explanation of the Table Headings

An explanation of the resource is under "Purpose." Who the resource is for is under "Audience." The current link is under "URL/Link." The format of the resource is under "Link To." How to get to the resources from the USAID homepage is under "Navigation from USAID." Whether the resource is directly relevant to the programming or procurement of food aid products is under "Relevant?" with "Y" meaning yes, and "N" meaning no. The thematic areas the resource falls into (e.g., procurement, products, implementation, etc.) is under "Tags." And additional notes on the resource or issues with accessing it is under "Notes."
